Message from founder

"My vision remains clear — to create sustainable business opportunities to share the wealth of the land with Aboriginal people, elevating Aboriginal businesses and creating further opportunities for Aboriginal people in mining." Daniel Tucker AM, sole owner and founder Carey Group

Carey is named after Lake Carey, a large inland salt lake which sits in the heart of West Australia's goldfields and has been used by the Wongatha people, for our cultural practices over thousands of years.

When I started in mining back in the 1980s, opportunities and attitudes in the resources sector in Western Australia for Indigenous people were very different to what they are today. The 1992 Mabo ruling created a new precedent for Indigenous rights and presented new opportunities for Indigenous people. The experience that I had gained in my years working at Windara (Western Mining Corporation, now BHP) in Laverton helped me to see the opportunity to establish an Indigenous owned mining contracting business. In 1992 I came to study Geology at Curtin University and returned home to Laverton to establish Carey Mining in 1995.

The first companies to give us opportunities to win contracts were AngloGold Ashanti (formerly Acacia Resources), Sons of Gwalia and Western Mining Corporation. Within six months, Carey had secured pioneering contracts at Barnicoat, Windara and Sunrise Dam Gold Mine. Since 1995,

we have built Carey into a robust, large business providing mining services, training, civil and marine construction services to major resource companies, State and Commonwealth governments in the Goldfields, Pilbara, Indian Ocean Territories and across Australia.

During 2020, Carey signed a full services mining contract with AngloGold Ashanti for their Golden Delicious open pit mine, continuing a 25 year relationship, one of the longest working relationships between an Indigenous contracting company and a global mining company in Australia.

Over the years, Carey has been honoured with many awards, but one of my proudest achievements has been the establishment of the Carey Education Trust in 2007. In 1980, my late wife Lynley and I were two of the first Aboriginal students to graduate high school in WA, so education was always very important to us and it has been a real sense of pride to watch our scholarship recipients go on to bigger and brighter achievements.

Our staff have been critical to Carey's success and I am extremely pleased that over Carey's lifetime, about 40% of our nearly 400 strong workforce, are Indigenous people. Carey is still a 100 per cent privately owned and managed Indigenous company and will continue to grow, providing bigger and brighter opportunities for future generations of Indigenous people.
